Hi Christine

Thank you very much for your order.

I am very sorry to say that we have some supply issues at the moment and we do not currently have any VN202 analysers available, as all available stock and production had been prioritised for supply to the hospitals for use on ventilators for COVID-19 patients.

We have nearly fulfilled our obligations with the hospitals and we are hoping to replenish our stock for the middle to end of July.

We can still supply the TEK-OX. This is the same sensor and electronics as the VN202. The only difference being that the sensor is within the device, as opposed to the VN202 having an external sensor connected via a cable.

Please let me know if you would like us to swap the VN202, cancel them or leave them on back order?

I am sorry for any inconvenience caused.
