Thank you very much for your paypal order.

I am very sorry to say that we have some supply issues at the moment and we do not currently have any VN202 analysers available, as all available stock and production had been prioritised for supply to the hospitals for use on ventilators for COVID-19 patients.

We have now fulfilled our obligations with the hospitals and we are hoping to replenish our stock for the end of July.

We can still supply the TEK-OX. This is the same sensor and electronics as the VN202. The only difference being that the sensor is within the device, as opposed to the VN202 having an external sensor connected via a cable.

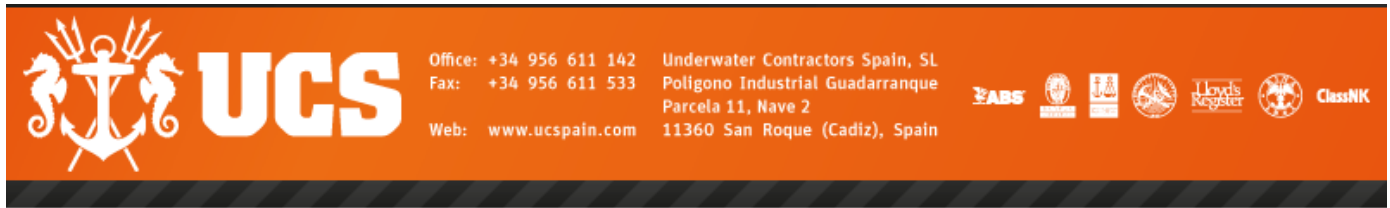

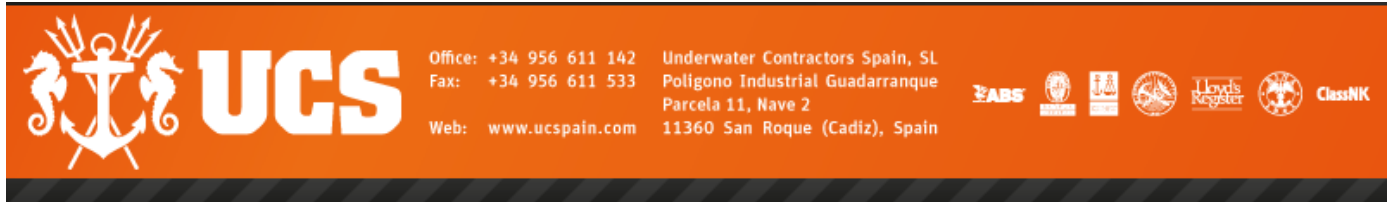
