Thank you for your enquiry.

We have multiple price breaks for both of these sensors which I will show below.

OOMLF102 sensor: 1 = £55.00, 2 = £49.50 each, 3 to 10 = £46.75 each and 11 or more = £44.00 each.

MAX-15LF sensor: 1 = £135.00, 2 = £121.50 each, 3 to 10 = £114.75 and 11 or more = £108.00 each.

The lead time would be approximately 5 weeks from the date of payment received.
