I hope you are doing fine. I get in touch because 2 of the oxygen sensors we are using with VN-202 oxygen analyzers in Fiji are giving 0.0 reading and cannot be calibrated. They have been checked as per possible causes listed in the user manual and it is most likely that the "Sensor is exhausted".

The sensors were purchased on 10/07/2018, Invoice No. VG00189310.

I would like to know what could be the possible cause for the failure (lack of use could be an explanation?) and also if you could quote 2 sensors (including the shipment to Spain).

Thank you very much for your email.

The sensors are guaranteed for 12 months, but typically last 2+ years, it is unusual for them to last anymore than 4.

Lack of use will not have any negative impact on the life of the sensors. Environmental conditions do play a large part in how long the sensors last; warm climates will usually shorten the life of the sensors or if the sensors have been left out in the sunshine.

My colleague Gail will send you a proforma invoice for the 2 replacement sensors you require.
