We are having some issues with stock at the moment, due to the pandemic. The production of sensors has been prioritised towards medical requirements.

We currently have stock of the R-33VAN(RP), but the R-22AT is likely to be the 1st week in October.

Unfortunately we do not supply the helium sensors for the ATA.
