It's been a month since I paid you and to date I have no merchandise. Do you find that normal?

No, it is not normal, but the supply situation of respiratory products is not normal at the moment. The information we have given you is directly from the manufacturer. Normally they keep to these dates, but they are extremely busy and their systems are unable to quote. I can only apologise.

You tell me that your manager has sold the goods. So I, who have already paid for the goods, am still waiting.

I did not tell you that anybody has sold the goods. I told you that one of our directors was chasing the manufacturer to obtain your order.

So today tell me concretely, the goods will be available under how long? if it's more than a week I cancel and thank you for refunding me.

I confirm to you I claim the reimbursement.

We are still unable to confirm the delivery date and in lieu of this I have cancelled your order, I have requested our accounts director to send you a refund and we will cancel our order with the manufacturer.

Working under these conditions is not acceptable. When we ask the customer to pay, we must also ensure that the goods are made available within a reasonable time.

I totally agree, unfortunately with the pandemic many of the manufacturers we are working with have had their systems, production and supply stretched beyond their capabilities.

I am sorry that this situation did not go better and I hope you manage to find an alternative solution.

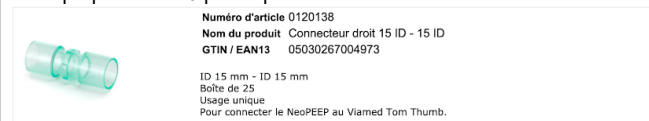
