Thank you for your enquiry.

Our records show you purchased the VM2101 in September 2009. I asked a technical colleague and he advised me that it has come to the end of it's operational life, the OLED has degraded and unfortunately these are not repairable.

The best solution is to suggest item 2810011, the MD300-C2 which is £25.50 each when purchasing one or item 2810050, the MD300-C29 which is £25 each when purchasing one. Carriage is free for these items and all prices are excluding VAT.

These are considerably cheaper now than when you bought yours in 2009.

Please let me know if you would like a proforma invoice or any further information. I have attached two leaflets for your information.
