Good afternoon Fraser,

I have checked with our export manager and he has informed me "you can calibrate the device in fresh air. However, if you are measuring higher percentage gas mixtures, then you will get a more accurate reading if you also calibrate in 100% O2, providing you have access to 100% O2. The calibration assembly helps connect it to some gas tubing via a flow meter".

I wanted to make you aware of this just in case this assists you to use the devices without any additional; expense.
