Please find attached some information concerning Maxtec oxygen analysers and monitors. The Handi+ is a self-contained analyser with integral sensor, which is designed to be disposed of when the sensor expires.

The lifespan of the device is dependent upon the amount of oxygen that the sensor is exposed to, which would typically be around 2-3 years with moderate use, or when the battery expires after approximately 1850 hours (74,000 operational cycles at 80 seconds each).

The Handi+ costs £130.00+VAT and we have these in stock. Are you looking to resell these as a distributor? If so and if you are looking at purchasing a number of units, we can offer distributor pricing on these, just let me know what kind of quantities you are looking at.
