Thank you for the new purchase order.

I'm not sure whether you are aware of the following. The DB200381 sensor has been developed to have a low magnetic signature, but we do not have the specialist facilities to test the magnetic signature of components pre production or the sensors post production.

However, we do submit specific components to the JFD for magnetic signature batch testing and approval prior to production. JFD also perform QA assessment of the sensors as part of their goods-in procedures.

In view of the above we cannot offer any performance warranty in terms of low magnetic signature. Can you please confirm that you wish us to process the purchase orders on this basis.
