I hope you're well. I just need to verify that you are OK with us proceeding at the correct 100-off price of £19.40+VAT following the price amendment that was notified in an email on 13th July 2020. The price on your PO is actually the price for 100+ of GOC5223 (R-22AVG type), which is slightly lower due to higher overall manufacturing volume.

Are we OK to amend the order by hand or do you want to re-send it?

Could I also ask that you add GOC5230 to your description, it currently states R-17AVG which is the model number for the Viamed branded version and could lead to confusion. It's fine if you want to keep both part numbers in there (GOC5230 / R-17AVG) as long as you reference GOC5230 somewhere. Thanks and I look forward to hearing from you.
