Dear Abdul and Simon,

Thank you for the return of the completed Terms & Conditions Form, and for confirmation of the specific delivery address. We will process the paperwork and I will be in touch shortly to advise when the device is being despatched, which will likely be early next week.

The Sale or Return process allows you to trial a new and unused device for a period of 30-days, covered under the Master Indemnity Agreement for the duration. I appreciate that 30-days is not a long time for assessment over 2 sites, but we would ask that you attempt to keep to this time-frame and schedule for the device to be moved between key evaluators during that period if possible. It may be possible to extend this, but I would ask you to contact me before the expiry date detailed on the MIA agreement if that becomes necessary.

You asked about the availability of quantity discounts, I am happy to be able to offer you a 10% discount off orders of 10 units or more. If you choose to purchase these devices, we ask that you keep the new unit that you have trialed and we would supply more devices to make up the balance.

The trial is without obligation to purchase. If the device proves to be unsuitable, we ask that you return it using a traceable courier service with the original accessories (with the exception of any disposable items) in its original packaging.

We will supply 1 device complete with cables, 1 reusable hand adapter, and a number of disposable thumb adapters. If you wish to purchase more of the disposable thumb adapters for a more extensive trial, these are available in packs of 50.

The device can be used in a table-top configuration, or can be pole mounted. Abdul, would you require an I.V pole mount sending with the unit?
