 - 4. Shall conduct vigilance as per NB-MED/2.12 and be responsible for the reporting of incidents involving products manufactured by Farstar Co Ltd so we may inform the

- 1) Relevant Competent Authority as per Article 10 of European Council Directive 93/42/EEC.
- 2) The Notified Body who issued the EC certificate.
