Further to your conversation today with my colleague Ryan regarding the TOF 3D Neuromuscular Monitor, please find attached some information and pricing, along with an Operators Manual to give you a better idea of the functioning of the device.

Viamed does not have sales reps in the field, so we can't visit to demonstrate the device, but we can loan you one for trial on a Sale Or Return basis. The Sale or Return process allows you to trial a device for a period of 30-days, covered under the Master Indemnity Agreement for the duration.

The TOF 3D is available as follows:

Instructions for Use

If you wish to use the twitch response monitoring functionality of the TOF3D, which is the recommended method, then you will need either of the following accessories:

- 2520110 Hand Adapter (reusable) @ £38.50+VAT each
- 2520111 Thumb Adapters (single use) @ £45.00+VAT / pack of 50

Note: you don't need to use both adapters together, you can choose either the reusable hand adapter or the disposable thumb adapters.

The device can be used in a table-top configuration, or can be pole mounted. We can supply a pole mounting bracket on loan with the device, along with a hand adapter and a few of the disposable thumb adapters.

Hi Stephanie,

I am contacting you following your enquiry regarding the Microstim DB3 Nerve Stimulator. Unfortunately, this device was discontinued as a medical product on the 17th May 2019 as it is not feasible to CE certify this legacy product to meet the requirements of the incoming European Union Medical Device Regulation (MDR). This means we can no longer sell new units as they will not have a valid CE certification.

The decision to discontinue the Microstim DB3 does not affect any devices already supplied, which were fully compliant with CE regulatory requirements that were in place when the devices were sold. Any devices currently in service bear a valid CE mark and there is no need to withdraw the units from use.

Although we can no longer sell new units, our stockpile of sub-assemblies does allow us to perform a fixed-cost repair for minimal cost, regardless of what is wrong with the device. Effectively, providing you can return a device to us with a serial number label on, you can get a good-as-new repair for just £45.00+VAT.

We are looking to replace the Microstim DB3 with a product from another manufacturer that already meets the requirements of the MDR. We were unable to find a simple nerve stimulator but we have found a potential solution in the form of a Neuromuscular Monitor, the TOF 3D, but this is a significantly more complex device and is consequently more expensive.

The price will be £1,400+VAT, which I appreciate is significantly more than the Microstim DB3 and this device may be over-specified for many applications but it is the only viable MDR-compliant solution that we have found.

We are still at a very early stage of the evaluation process and we have not yet done the manufacturer sales training but hope to bring this to market in the coming months. I have attached some information illustrating the device, if this is of interest and you would like to offer any comments, do please get back to me. Likewise, if you would like me to send a copy of the Instruction Manual to give you a better idea of how the device functions, please let me know.
