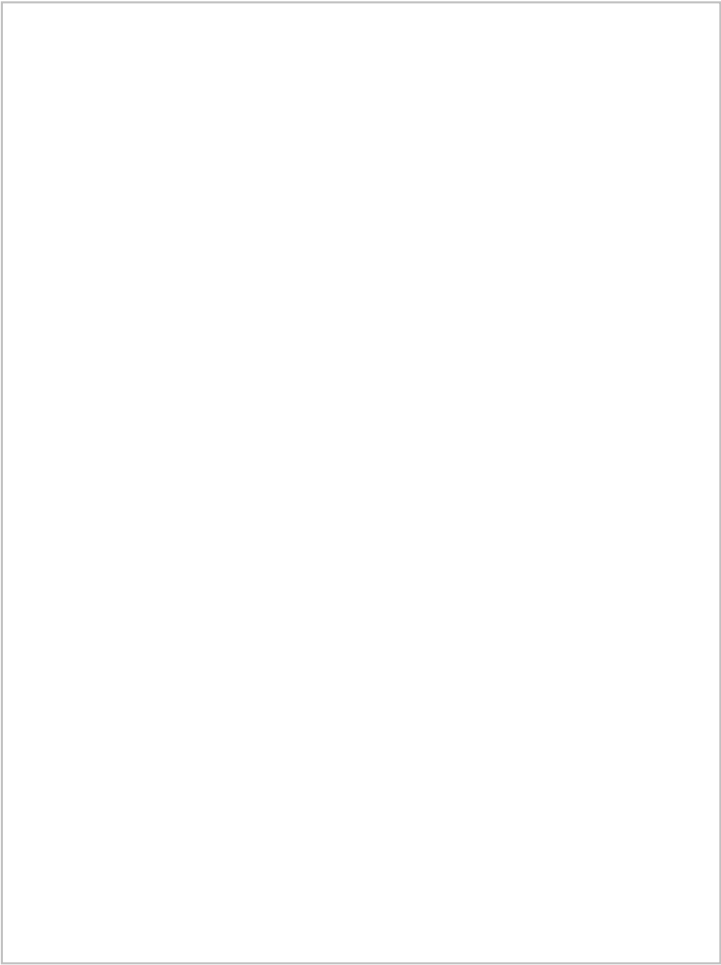

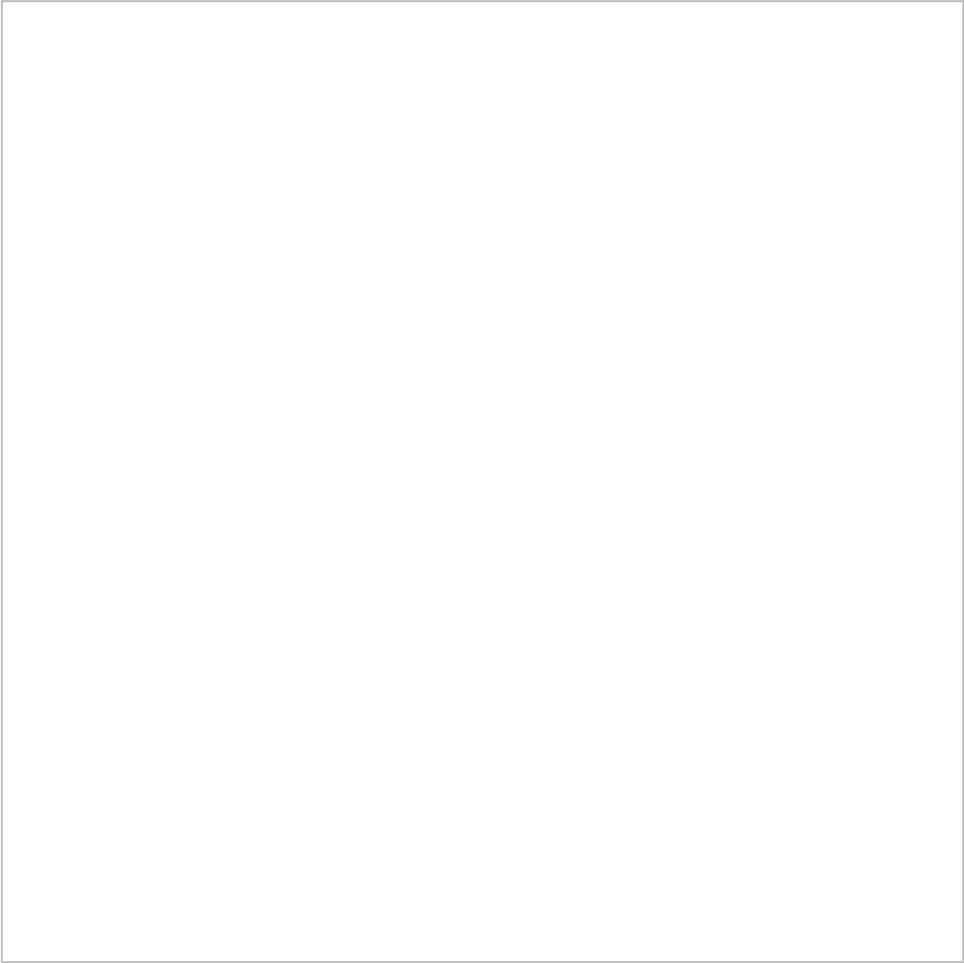
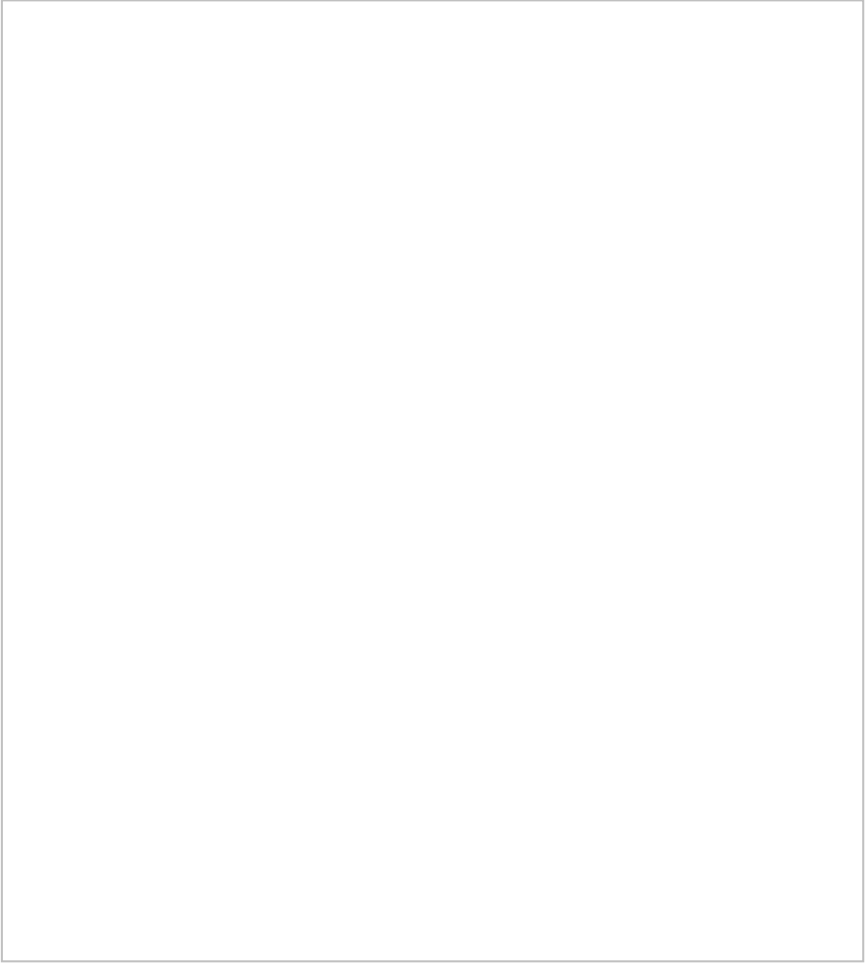
Hi Ago

I am very sorry for the late response on this. As I mentioned before Precision had to withdraw from the market when their notified body (Lloyds) decided to stop working in the medical industry. We believe they will be able to start supplying again in the near future, but there is no definitive date, so until then we can supply the same blenders but with a Maxtec label. Unfortunately Maxtec have decided to increase the pricing.

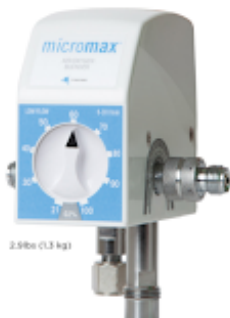

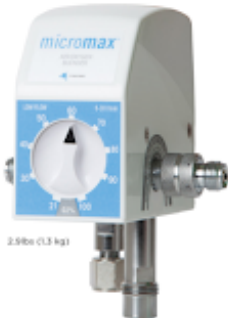
