Hi Peter,

Following the receipt of further information from MIPM, I have been able to update the PAQ2 form with additional information concerning infection control, section 6.

Please see attached revision, dated today to supersede previous version. The updates are as follows:

The manufacturer, MIPM, has provisionally approved Gama Healthcare Clinell Universal Wipes based on assessment of the composition of the wipes and the device but has not yet issued a written declaration of compatibility. Once we receive this, we will forward it on.

Q6b: Also, please provide specific detail of the plastics used in all rigid external surfaces:

A: 1)The upper and lower casing including the battery cover is produced from amorphous thermoplastic alloy (polycarbonate + ASA)

- 2) The upper exposed surface of the membrane keypad is produced from textured hardcoat polyester film.
- 3) The transparent display protection window is produced from 2mm PMMA (Polymethyl methacrylate acrylic glass).

The device is just going through reprocessing, which includes cleaning and disinfection. We should be able to despatch tomorrow or Monday to be with you by Tuesday at the latest. I will address it directly to you, care of MEMD.
