Thank you for your email confirming that we should use purchase order 319122992 (for the period 01/04/21 -31/03/22) as the current active order and consider purchase order 319109663 (for the period 01/04/20 - 31/03/21) as a missed service year due to COVID.

Hi Danielle,

Due to complications caused by COVID-19 and the restrictions that it imposed upon us, Viamed has not been able to complete field service visits over the last year. With restrictions coming to an end, we are now looking to resume service visits.

We have on our system the following 2 purchase orders for service of the Viamed resuscitation cabinet systems in Maternity at Royal Albert Edward Infirmary (attached):

- Ref 319109663 dated 20/10/2020 for the service period 01/04/20 31/03/21 (which has now passed).
- Ref 319122992 dated 18/06/2021 for the period 01/04/21 31/03/22.

As the first service period has passed, I suggest that we need to cancel that order and consider it a missed service due to COVID-19, then get these systems serviced as soon as possible on the second purchase order to get back on track.

Please could you confirm whether this is the best resolution for the Trust or would you prefer us to use PO Ref 319109663 for the 2021 service visit (likely to be completed September 21) and forward date PO Ref 319122992 for September 2022?

I also have one more query: the delivery address on PO Ref 319122992 is to Buckingham Row WN1 1XX, would this be best changed to Maternity Unit at RAE Wigan?

Thanks in advance and I look forward to hearing from you so that we can move forward with this and get these systems back into the servicing schedule.
