I will answer your questions as follows:

I will update your proforma invoice to show 4 x R-23V and I will update carriage charges if necessary.

We are unable to accept Western Union. You can pay by bank transfer or PayPal. Paying by PayPal incurs a 6% fee of the total order. If you would like to pay this way, I will need to update your proforma invoice to show this. Obviously bank charges would be removed if PayPal is your preferred method of payment.

Bank charges - the \$25 is the charge incurred for us to receive your payment. If you pick up all charges when you make a payment this will not occur. If you are unable to select remitter pays all charges then we will have to pass this charge on to you. It is normal business practice and company policy that bank charges are paid by the customer.

As you are aware, these sensors have a warranty period of 15 months from date of shipping to you.
