Dear Emma

Thank you for the new purchase order, but under the current conditions we cannot process it.

1) The pricing is again incorrect, it should be £54.00 per sensor. Carriage charge is £9.00 by UPS Standard Service

We do maintain an emergency stock of 25 sensors for you, so if required we could ship these as part of the same order at £54.00 each plus £9.00 carriage charge.

2) The delivery terms cannot be met, it is far too short for the production of a bespoke OEM oxygen sensor. We usually state 4 -6 weeks. However, under the current pandemic situation it is typically 8 weeks.

3) The standard JFD LTD STANDARD TERMS & CONDITIONS OF PURCHASE JFDG-LEG-TC-001 Revision 03 have been supplied to us, rather than the amended version agreed upon with Duncan back in March 2018:

**3.1** Currently the sensors are supplied CPT, but looking at item 3.1 it infers that we cover the insurance. Do you want us to add the UPS insurance at 1% of the invoice total, as stated on the price list? If so, could you please add it to the purchase orders or I could update the price list **JFD has its own transportation insurance.**

**3.10** This would be difficult to apply in regard to the sensors and we would deliver goods as per the specifications. However, this clause is open ended as far as costs are concerned. **Clause 3.10 deleted.**

**8 (8.1 & 8.2)** The sensors are a custom device made to your specifications. So, if the product is supplied as per the specification we can't be expected to accept returns, other than in respect of warranty claims. **Clause 8 deleted.**

**14.4 & 14.5** Again as the sensors are a custom design we can't be expected to be subject to these clauses. **Clauses 14.4 & 14.5 deleted.**

4) The specification is not attached. Although we can only supply to our specifications:

**Specification Datasheet - 8010050 JFD Ltd. DB200381 Oxygen Sensor V2.0 6 th May 2019**

5) As discussed on previous occasions we cannot offer any guarantees regarding the sensors being non-magnetic. They are produced with the critical components that have been tested by JFD.
