Hi Albert

I would recommend you switch to the R-22AVG, as it is very similar to the R-22AV with the same output specifications, but it has a specified pressure range of 0.6 to 2 bar (Absolute Pressure). Although I am sure the R-22AV would be okay, it is not specified for use outside of atmospheric pressure.

I have attached the specifications for the R-22AVG, please let me know your thoughts?

Please note that the sensors are pressure sensitive, as they actually measure the partial pressure of O2, so it is important that you calibrate and then measure in the same environmental conditions.

Please let me know if you have any questions and please let me know how you would like to proceed with your proforma invoice.

We do not have a sensor in the 9-11/8-11mV.

If the connector is not important, then we can supply the R-17A-LV which is 7-11.5mV, but it has a 3.5mm jack socket instead of the molex connector.

With regards to pressure, do you mean 0.4-1 bar actual pressure or gauge pressure (above ambient)?

I think the R22AV would fit our needs, but the ideal range for us is 9-11 // 8-11 mV, may you have a similar model in this voltage range?

The other important spec for us is the pressure range, is it similar to the R22AVG? I can't see this specification in the sheet you sent me, our max working pressure is 0.5bar, so a suitable range would be 0,4//0,5 – 1.00 bar

Both sensors are in stock.
