Our prices have been stable since APD started purchasing back in 2014, as you will appreciate this is a very long time. We have always had pricing based on order size, see attached price list. We did overlook this with APD due to Martin's view in regard to annual quantities, but they have reduced year-on-year. In addition, we do need to bring the processing of the APD orders into line with our ISO procedures...

I'll be reviewing all prices soon, as you know there have been significant general increases in costs. In regard to your next price list I'll remove the APD8 as previously discussed and in line with the historic purchase order quantities I suggest we remove the following price bands for the APD16:
