We have received the stock of connection tubing 3m sterile packaging in relation to your order RTFE400225640
from January. Unfortunately, we are no longer able to supply this item in boxes of four (though we can provide you with the remaining 3 boxes of 4).
In order for us to ship your order as soon as possible, please could I suggest that instead of ordering 653301 x 8, please could you amend your order to 653301 x 3 and 653301-15 (these are boxes of 15) x 1
This would mean you will receive 27 units instead of 32, but it also means we can ship your order in the next day or two.
Another positive point is that a pack of 15 (the only format we will be able to sell this item in) is cheaper per unit than the pack of 4.
