I hope you can help with a discrepancy regarding the labeling of the Max-250+ sensor (R125P02-11) that was pointed out to us by a customer.

The images that we use to promote this sensor show the model 'MAX-250+' on the labelling (first image below). The sensors that we currently have in stock simply show 'MAX-250' (second image below).





This has caused some confusion with a customer, who is querying whether the specification remains the same.

Can you confirm that this is simply a change to the labelling and nothing more?
