Submission deadlines for EEE data are listed below. Reminder emails are sent from

WeeeCare to the primary contact, in advance of each quarterly deadline.

Q1 14 th April

Q2 14 th July

Q3 14 th October

Q4 14 th January

Please note: some submissions are annually by the 14 th January

7. Length of time WEEE Compliance documentation must be kept

All WEEE compliance raw data and submissions must be kept for a minimum of 4 years

8. Location of WEEE Compliance data

9. Batteries

N.B. If Viamed Ltd imports (or manufactures) any batteries and supplies them to customers in the UK with (or without) any equipment/EEE [currently not the case], then we will have to notify WasteCare and report on these batteries separately.

10. Packaging

N.B. If Viamed Ltd reports more than 50 tonnes of product/EEE to WeeeCare, we must also

assess the total amount of packaging placed on the UK market in the previous calendar year.

This is because if Viamed Ltd has an annual turnover of more than £2million [currently the

case], and also handles a total of 50 tonnes (or more) of packaging on the UK market, then we must report our packaging as well to WasteCare.
