Hi Graham

Thank you for your email and I apologise for the delay in my reply.

The Tee that is part of the sampling device (Quick-OX & DINKIT) is slightly different to the A-268, as it has a series of valves inside. However, I do not think you require the valves, I think you would be best with the standard A-268 Tee and some barbed connectors:





This system would allow you to add your tubing to either side of the TEE, having the barbed connector on the other side eliminates a potential venturi effect which could lead to a diluted reading, but will still allow the gas to escape and not create too much back pressure.

I can price up the parts for you, but can you tell me if you already have the TEK-OX analyser or should I put a package together for you?
