Further to our conversation yesterday, please find attached some additional information concerning the TOF 3D Neuromuscular Transmission Monitor.

The TOF 3D Neuromuscular Transmission Monitor costs £1,400+VAT each. There are a three different monitoring accessories available separately to allow secure placement of the accelerometer for accurate twitch response monitoring:

- 2520111 - Thumb Adapters (single use) @ £45.00+VAT / pack of 50
- 2520112 - Eye Adapters (single use) @ £82.00+VAT / pack of 50
- 2520110 - Hand Adapter (reusable) @ £38.50+VAT / each

Also, an optional pole mount is available for use with vertical/horizontal poles and standard medirail @ £66.75+VAT.

Note: for hand placement, you can choose either the reusable hand adapter or the disposable thumb adapters, they are not used together. I have attached an Instruction Manual for reference, which illustrates the placement positions.



The TOF3D uses standard paediatric electrodes, which Viamed doesn't supply, but which are readily available through your usual supply chain channels.

Unfortunately, Viamed does not operate with field sales representatives, so is unable to provide on-site training for this device. Viamed asks that the requisitioner gives due consideration to this prior to purchase.

If you would like a formal quotation, please advise which of the monitoring accessories to add to the quotation and I will send that on to you. If you have any questions please do not hesitate to contact me.
