## Terms and Conditions of Quotation: Road Logistics

- 1. The information provided in this proposal, including but not limited to rates, services and company details, is strictly confidential. It is provided for the intended recipient only and must not be distributed to or shared with any third parties.
- 2. All information has been compiled with greatest care to ensure its integrity. However, Kuehne + Nagel reserve the right to make necessary corrections in the event of any data entry errors.
- 3. The choice of underlying carriers is entirely at Kuehne + Nagel's discretion. Part and full load services will be subcontracted to Kuehne + Nagel approved suppliers.
- 4. Less than full load shipments will transit Kuehne + Nagel cross docking facilities which also handle hazardous goods, glass and plastics. Procedures are in place for separation on hazardous goods.
- 5. Subject to mutual agreement of the rates and service offering, the road freight rates remain valid for 7 days from date of final acceptance by both parties, or as per any specified validity dates agreed.
- Kuehne + Nagel's quotation do not include special charges, such as but not limited to, insurance premiums, inspection charges, documentation handling, processing or similar services, and/or any taxes, duties, tolls, SECA surcharges or similar costs and assessments unless described.
- 7. All government, port or other imposed fees, charges or expenses, which may or may not be included in this quotation, and all surcharges are subject to change.
- 8. Rates are inclusive of all road taxes and tolls. However, should road taxes change at any time, the rates will be modified accordingly.
- 9. Unless explicitly mentioned in the offer, rates apply to general cargo only and do not include high-value cargo, perishables, thermo, valuables, temperature controlled, and oversized, over-length, or out of gauge cargo.
- 10. In the event that Kuehne + Nagel incurs any additional costs as a result of any changes in legislation, applicable regulations or as a result of any actions by any government or other body, then such costs shall be charged to the customer and/or the rates shall be subject to change.

- 27. Any Customs clearance fee that is covered in the quotation includes 3 (three) HS codes. Any additional HS code will be charged as per valid tariffs
- 28. In the event of Customs clearance delay caused by customer or 3 party resulting in storage at KN Hub a charge will apply This will be applicable after 3 days at a charge of GBP10.00 per pallet per day
- 29. A demurrage charge is payable by the client on all delays directly or indirectly associdated with Customs. In the event of transit delay a charge of GBP 50.00 per hour or part thereof will be incurred.
- 30. This quotation is based only on DAP for export shipments or FCA for import shipments
- 31. We complete the customs declarations based on information given by yourselves which is gained from Commercial Invoices, Packing lists and any other customs details or instructions you provide. If we receive any incorrect information that results in charges or fines, from customs or other parties, the charges will be passed on to you in full. An example of this could include, but is not limited to; stating the Country of origin incorrectly, stating any incorrect values or not declaring the need for an export license.
- 32. We require a Power of attorney/Letter of empowerment (POA/LOE) in order tocomplete any customs declarations. If the terms of shipment you are shipping under mean that the other party in the transaction is responsible for a declaration, and the other party wishes to use Kuehne+Nagel for this, they must complete and return a POA/LOE promptly. Any delay or refusal to complete the power of attorney could result in the goods being returned to you at your cost without notice.

If the other party in your transaction already has a nominated customs broker the power of attorney will not be needed, but you will need to advise us of this prior to collection, along with any special instructions regarding clearance, such as, but not limited to; a specific place to present for customs clearance, a specific routing and/or the need for a transit document for that specific shipment. Requests like these mentioned could mean that the shipment will need to be moved in a different way and is not possible on the service originally quoted, therefore a new quotation will need to be provided.
