3. Hazards identification

Physical:

Do not short circuit, puncture, incinerate, crush, immerse, force discharge or expose to temperatures above the declared operating temperature range of the product. Risk of fire or explosion. The Lithium-Ion batteries described in this Material Safety Data Sheet are sealed units which are not hazardous when used according to the recommendations of the Manufacturer.

Under normal conditions of use, the electrode materials and liquid electrolyte they contain are not exposed to the outside, provided the battery integrity is maintained and seals remain intact. Risk of exposure only in case of abuse (mechanical, thermal, electrical) which leads to the activation of safety valves and/or the rupture of the battery container. Electrolyte leakage, electrode materials reaction with moisture/water or battery vent/explosion/fire may follow, depending upon the circumstances.

4. First-aid measures

In case of battery rupture or explosion, evacuate personnel from contaminated area and provide maximum ventilation to clear out corrosive fumes/gases and pungent odour.

After Eye contact:

Flush with plenty of water for several minutes while holding eyelids open. Get immediate medical attention if irritation persists.

After Skin contact:

Remove all contaminated clothing and shoes. Immediately wash with water and soap and rinse thoroughly. Do not apply greases or ointments. If irritation occurs, get medical attention.

After Inhalation:

Remove victim to fresh air and ventilate the contaminated area.

Give oxygen or artificial respiration if breathing is difficult. Seek medical attention.

After swallowing:

Get immediate medical attention.

Assure that the victim does not aspirate vomited material by use of positional drainage.

Assure that mucus does not obstruct the airway.

5. Fire-fighting measures

Lithium ion batteries contain flammable electrolyte that may vent, ignite and produce sparks when subjected to high temperature (>150°C (302°F)), when damaged or abused (e.g. mechanical damage or electrical overcharging); may burn rapidly with flare-burning effect; may ignite other batteries in other proximity.

7. Handling and storage

Information about fire and explosion protection

Batteries may explode or cause burns, if assembled, crushed or exposed to fire or high temperatures. Do not short or install with incorrect polarity.

Conditions for safe storage, including any incompatibilities:

Requirements to be met by storerooms and receptacles

Store in a cool, dry and well-ventilated place

Information about storage in one common storage facility

Batteries must be stored in a temperature range of $-20\text{ }^{\circ}\text{C} \sim 45\text{ }^{\circ}\text{C}$.

If the battery has to be stored for a long time (Over 3 months), the environmental condition should be:

Temperature: $23\pm 5^{\circ}\text{C}$

Humidity: $65\pm 20\%\text{RH}$

The voltage for a long time storage shall be $3.80\text{V} \sim 3.95\text{V}$ range.

Read and observe the following warnings and precautions to ensure correct and safe use of Li-ion batteries.

Do not immerse the battery in water or wet it.

Do not use or store the battery near sources of heat such as a fire or heater.

Do not use any chargers other than those recommended.

Do not reverse the positive (+) and negative (-) terminals.

Do not connect the battery directly to wall outlets or car cigarette-lighter sockets.

Do not put the battery into a fire or apply direct heat to it.

Do not short out the battery by connecting wires or other metal objects to the positive (+) and negative (-) terminals.

Do not pierce the battery casing with a nail or other sharp object, break it open with a hammer, or step on it.

Do not strike, throw or subject the battery to sever physical shock.

Do not directly solder the battery terminals.

Do not disassemble or modify the battery in any way.

Do not place the battery in a microwave oven or pressurized container.

Do not use the battery in combination with primary batteries (such as dry-cell batteries) or batteries of different capacity, type or brand.

Do not use the battery if it gives off an odor, generates heat, becomes discolored or deformed, or appears abnormal in any way. If the battery is in use or being recharged, remove it from the device or charger immediately and discontinue use.

Do not use or store the battery where is exposed to extremely hot, such as under window of a car in direct sunlight in a hot day. Otherwise, the battery may be overheated. This can also reduce battery performance and/or shorten service life.

If the battery leaks and electrolyte gets in your eyes, do not rub them. Instead, rinse them with clean running water and immediately seek medical attention. If left as is, electrolyte can cause eye injury.

Use the battery only under the following environmental conditions. Failure to do so can result in reduced performance or a shorten service life. Recharging the battery outside of these temperatures can cause the battery to overheat, explode or catch fire.

Operating environment:

When charging the battery: 0°C~45°C

When discharging the battery: -20°C~60°C

When stored up to 30 days: -10°C~45°C

When stored up to 90 days: -10°C~35°C

Keep away from heat, avoiding long time exposure of sunlight.

10. Stability and reactivity

Chemical stability:

Product is stable under conditions described in Section 7

11. Toxicological information

The CT-2500 Lithium Polymer batteries do not contain toxic materials.

Signs & symptoms:

No signs and symptoms apply, unless the battery ruptures. In the event of exposure to internal contents, corrosive fumes will be very irritating to skin, eyes and mucous membranes. Overexposure can cause symptoms of non-fibrotic lung injury and membrane irritation.

Inhalation: Lung irritant

Skin contact: Skin irritant

Eye contact: Eye irritant

Ingestion: Tissue damage to throat and gastro-respiratory tract if swallowed

Medical conditions generally aggravated by exposure:

In the event of exposure to internal contents, eczema, skin allergies, lung injuries, asthma and other respiratory disorders may occur.

12. Ecological information
