Further to our discussion can you please clarify the following:

On the list of definitions the hose length is stated as 1000 / 1300 +/- 50mm.

Should this be 1000 / 1500 to reflect the two sizes at 1m and 1.5m

Or, does it mean that the 1m hose can be extended to 1.3m? If so, what are the measurements for the 1.5m hose, 1.5 to circa 1.95?

Also the PEEP valve is stated as 0-15mbar, at what flow is this?

On the performance test report the PEEP value goes to circa 43 mb at 15 lpm.
