### PLEASE NOTE IMPORTANT INFORMATION:

#### - Dual Use Legislation is now in force

  - Removable/replacement light sources (e.g. traditional gas discharge lamp or LED light source) should be reported in cat 13.

Classify as B2C gas discharge lamps, LED light sources (lamps) and sodium lamps (includes retrofit and non-retrofit lamps). Classify as B2B floodlights for stadiums and lamps used in cinema projectors.
