Dear Valued Customer,

We herewith wish to inform you that our EnviteC- Wismar business, part of Honeywell, is migrating to SAP's Enterprise Resource Planning (ERP) environment early in October 2019. As we near our implementation go-live on October 2019, we are working to make sure our transition is as simple as possible for you.

We would like to share more detail about customer benefits, as well as planned system conversion activities that will temporarily affect business during our transition.

Benefits of Transition to SAP

For customers, our move to SAP will bring a number of benefits, including:

- Increased reliability of information and responsiveness to customers
- Convenient and timely access to accurate information based on each customer's record — includes information about pricing, terms, product availability, specifications, promotions and discounts.

Expected Changes

Our move to SAP will bring several changes for EnviteC- Wismar customers. Changes include:

- New customer forms — Our business will introduce a new design and format for invoices, order acknowledgements, and packing slips. We will distribute a sample of these new forms in advance of our go-live.
- New Honeywell part numbers — as not otherwise mentioned in the appendix of this letter, the current part numbers will be extended by a leading letter E (i.e. 01-00-0013 will change to E01-00-0013). The customer reference part numbers as far used for customized products will remain unchanged.
- New customer debtor numbers — We will assign new customer numbers in our SAP system;
- Sending invoices

Because many of our products need to be traceable for regulatory purposes, SAP's serial number management are going to be used when migrated, which allows a one-to-one relation between serial number and product. **This means that customer-defined serial number systems or serial number ranges can continue to use only if they do not conflict with other serial number systems or serial number ranges.** On the example of the EnviteC Oxygen Sensors, by default, each item receives a consecutive six-digit number as a serial number. The alphanumeric prefixes or suffixes used as a supplement to this consecutive number remain unchanged; only the 6-digit number sequence will be managed by the SAP system in the future.

We assume that, in addition to the regulatory necessity, it is also in the interest of our/your customers to improve the traceability of our products. Please let us know by 13/09/19 if conversion to a unique serial number if not yet already applied is causing a problem for you or your customers.

Transition Activities

Beginning October, 2019, we will move data from our existing systems to our new SAP system, therefore we might encounter some small disruptions in our business. However, we have been working for several months to ensure that you will experience no disruption in service. Preparation includes:

- business contingency plans and risk mitigation plans
- employee training
- functionality testing

We are confident that these measures position us for a successful SAP transition within the scheduled timeframe. However, if there is a delay, we are able to serve your needs until the new system is operational.

We highly appreciate our business relationship thus, we will make our best to adapt our delivery times in order to ensure a stable business with our customers. Early orders would be helpful to improve lead times and processing time of your requests.

Please prepare your company for the changeover and inform us until September 13th in case of unresolved problems with the transition at envitec.info@honeywell.com .
