Hi Mehul

As you know we supplied 300 x T-7 (ref. MOX-4) oxygen sensors at short notice to try and ease the emergency situation. In total you ordered 2,200 sensors, so there was a balance of 1,900. After subsequent discussion I was under the impression that you no longer needed the sensors and we were to refund the balance payment.

If the situation is now that you may need some or all of the remaining 1,900 sensors can you please provide me with an update of your requirements in terms of timescales and batch quantities..

As discussed, we already have production backed-up for several months. However, I may be able to make a few adjustments in a few weeks time.
