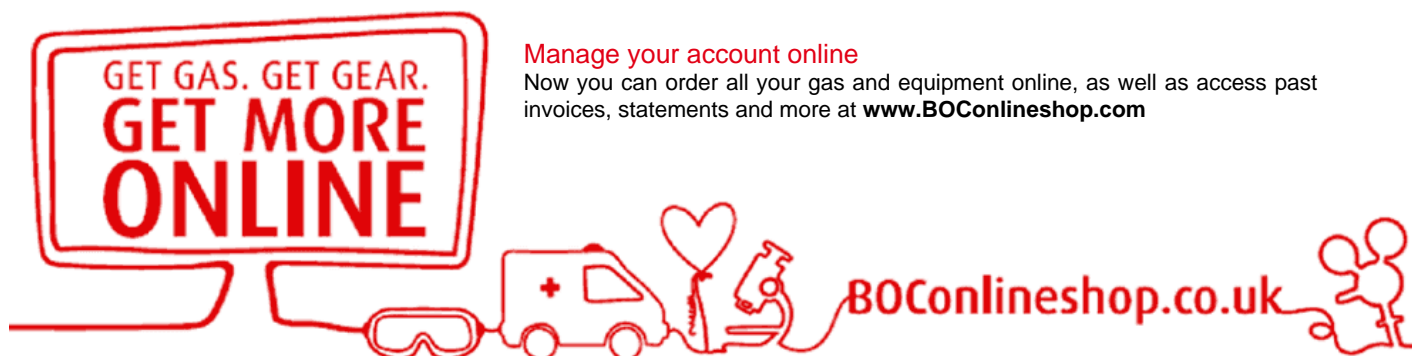

Frequently asked questions

Rental

- As per our conditions of sale, all BOC Cylinders/Containers are rented to you and remain BOC property. Each cylinder includes an individual serial number and it is your responsibility to keep control of this individual cylinder
- Rental will be charged on each cylinder on either a monthly or annual basis
- Monthly rental will be charged for the highest number of cylinders held per gas type within the month in arrears
- Annual rental is charged one month in arrears and eleven months in advance. When rental is charged annually an anniversary date is set for the product type/size. If there is an increase or decrease in holdings of that particular gas type/size this will result in pro-rata debits/credits to align to the anniversary date.
- Rental will automatically renew on your original anniversary date unless the cylinder has been returned.

Fees

- The Environment and Energy Surcharge is applied to recover exceptional movements in energy costs. It is increased or decreased in-line with current costs on various gas types Including Oxygen, Nitrogen, Argon, CO₂, Hydrogen and Propane.
- Late Payment Fee – If your invoice is not paid by the due date on the front of this invoice, you may be liable for a late payment fee
- Non DD Fee – For payment by any other means than Direct Debit, BOC reserves the right to charge any additional costs BOC incurs as a result of such payment
- Fixed charge – A fixed charge is applied to every order for delivery or collection irrespective of the size or type of the cylinder supplied
- Paper Invoice Charge – BOC's preferred method of invoicing is electronic. BOC reserves the right to charge any additional cost BOC incurs in generating paper invoices or non standard invoices for the customer.
