Thank you for your email.

Yes, unfortunately the Microstim DB3 Nerve Stimulator was discontinued as a medical product on the 17th May 2019. The reason being is that it is not feasible to CE certify this meet the requirements of the European Union Medical Device Regulation (MDR).

The decision to discontinue the Microstim DB3 does not affect any devices already supplied, which were fully compliant with CE regulatory requirements that were in place when sold. Any devices currently in service bear a valid CE mark and there is no need to withdraw the units from use.

For any of the units you currently have, we can continue to supply spare parts and servicing for a minimum of 7 years.

However, we unfortunately do not have an alternative product to offer.

Please accept my apologies for any inconvenience caused. I can be of further assistance please let me know.
