The message from one of our directors is as follows:

Whilst every reasonable effort shall be made to keep to any estimated delivery date, time of delivery shall not be of the essence and that Viamed shall not be liable for any losses, costs, incurred by the Buyer or any other person or Company arising directly or indirectly out of any failure to meet any estimated delivery date.

Your recent order, on invoice RVM143464-1, was unfortunately delayed due to a batch of materials that did not pass inspection prior to manufacture, unfortunately Viamed were not made aware of this as we do try to keep our clients informed to the best of our ability, we are now taking steps to improve our internal systems; to systematically chase suppliers and keep clients informed when changes are placed. We are aiming to implement these changes over the next couple of months.

Our directors have agreed that as a one-off gesture of good will, we would be willing to provide you with a credit on your account for 50% of the penalties = EUR €145.95


