Dear Juliana Pérez,

Please find attached my correction plan for the minor issue noted in our last audit.

Regarding our current scope, we are no longer manufacturing medical products. Production of our own devices ceased in 2017/2018, and they have effectively reached their end of life. We are still providing service on a limited number of units in the field and continue to perform the yearly PMS report. However, the time is right for us to update our ISO scope accordingly.

Our current scope includes:

"Service of Supra-Maximal Peripheral Nerve Stimulators, Simulation Equipment, Infant T-Piece Resuscitators, Apgar Timer, and Resuscitation Cabinets. Distribution and Service of electromedical devices."

We would like to update this to:

"Distribution and Service of Medical Devices and Products."

Although we still produce a small number of V1000 simulators, they are not classified as medical devices. We continue to service approximately 30 Infant T-Piece Resuscitators annually, which could be covered under "Service of Medical Devices and Products."

Our primary focus now is distributing equipment from other manufacturers and managing their customer returns — whether through servicing, repair, or coordinating returns to the supplier, along with providing them feedback.

On another note, our ISO system is somewhat unique in how it complies with regulations, which can take an auditor some time to fully understand. I am looking to transition Michael Lamb into a role where he can actively engage with ISO auditors and demonstrate our system. Michael has already completed a 13485 auditing course and is capable of performing internal audits. I would like him to take on a more prominent role in running our BSI audits. For this reason, would it be possible to have one of the auditors we have worked with recently for the next audit? Their familiarity with our system would provide an ideal environment for Michael to step into hosting the audit, while I remain available as needed.

I discussed this with Christopher Serna, who suggested I reach out to you.

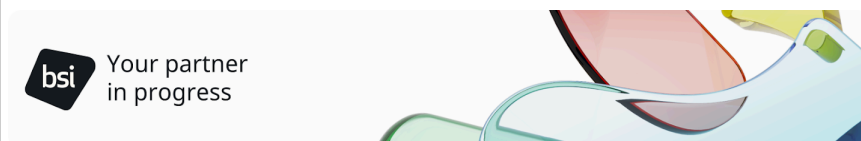

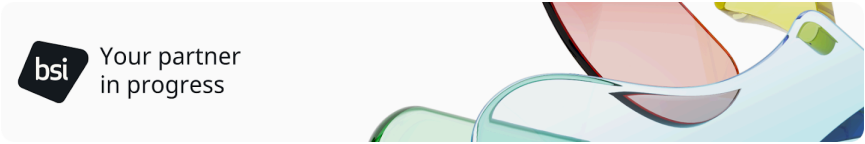
