Hi Darren,

Please find attached the requested documentation concerning the Microstim DB3, including a completed checklist.

The only area where Viamed products do not fully comply is the requirements for cleaning as Viamed has not tested any of its products using Actichlor. Due to the wide range of cleaning agents available, testing every Viamed product against every cleaning product on the market is not a viable option.

As such, Viamed have adopted a single high-level broad-spectrum disinfectant: TecCare. We adopted this particular brand following consultation with an NHS Trust that has gained national recognition for its innovation and approach to infection control. The Trust in question has done considerable work in evaluating disinfectants and decided upon TecCare, and now demonstrates an impressive record in the control of infection in the Trust.

Chlorine based cleaning solutions will likely prove benign to the equipment in question in the concentrations stated, however, we cannot categorically certify their use.
