To remain on the MIA register you must provide an up-to-date copy of your Public and Products liability certificate(s) for a minimum of £5m (GBP) or equivalent per claim to: mia@supplychain.nhs.uk prior to the expiry of your current certificates.

It is within the supplier's and the Trust's interest to ensure that re-submission of documentation is done in a timely manner and prior to Insurance policy expiry to avoid re-work and disruption to the over-arching agreement. A failure by a supplier to provide insurance renewal certificates will result in NHS SC terminating the supplier's overarching Master Indemnity Agreement and removing their details from the MIA register.

Good morning Catrin

Thank you for sending us your insurance certificate.

I have checked your insurance certificate and note that Products liability & Public Liability insurance amount has the indemnity limit of £5m. Please note that as per MIA Ts and Cs that you have signed to, it is the supplier's responsibility to ensure that there is sufficient insurance in place (**min. £5m per claim for public liability** and **product liability** each) to cover your liabilities and ensure that you have not reached the limit of your cover during one period of insurance.

Last year's insurance certificate from Viamed (attached) looks a little different and does specify that the £5M cover is per claim / occurrence. Would you be able to arrange something like this again?

Please discuss with your insurer and confirm whether the £5M cover for Product and Public liability insurance is per claim, not just a total limit for the period. We will not be able to update the MIA Register with your details until we have evidence that sufficient insurance cover is in place.
