In March we ordered 4 of the R-47V O2 cells, the PO number is - P0004704. The last one of the 4 in our stock had a manufacture date of 2024-04-01 on the o2 cell. The box it came in had a manufacture date of 2025-03-01.

Also, the o2 cell inside was a Honeywell (O0MLF204) I believe this an equivalent for the R-47V cell.
