Subject: Biocompatibility tests for Viamed Ltd.

Dear Sir/Madam

GE have passed your details on to us and they say that you may be able to assist in carrying out Biocompatibility tests on our behalf.

We have a product in development, which is an eye mask for use on babies (see photo attached). It consists of a spun-laced bandage fabric with a protective eye patch on the inner side. The mask is attached to the patient by use of Velcro fastenings, which have been ultrasonically welded to the spun-laced fabric.

In line with our CE certification we need biocompatibility testing carried out on the product. The product is usually attached to patients for 2 – 8 hrs. I believe that the first two biocompatibility classifications of <24hrs and 1 –30 days application are identical in terms of the tests that need to be carried out, therefore we may as well cover both. Can you please confirm/advise if the following are the tests that need to be carried out?

Cytotoxicity tests to ISO 10993-5

Sensitization tests to ISO10993-10

Irritation tests to ISO10993-10

Also are Chemical Characterization tests to EN ISO 10993-18 required?

Can you please provide a quotation for the test, together with a lead-time for them to be carried out? Do you routinely test to GLP, or are there addition costs involved?
