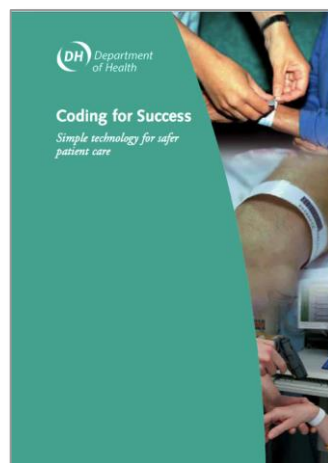


# Electronic invoicing landscape in the European Union

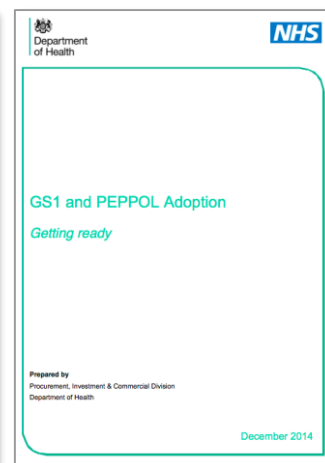

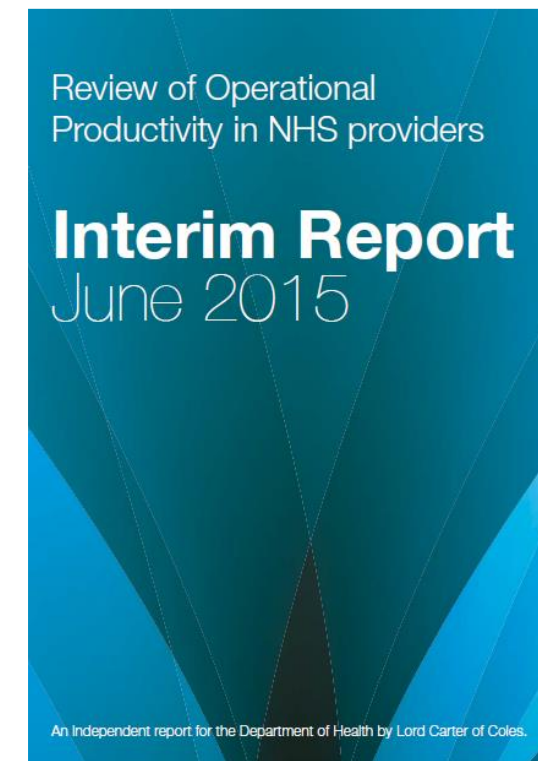

# Department of Health - Objectives

- *Reducing Inventory levels, improving Inventory flow and reduction in Inventory waste*
- *Reduced supplier complexity, increasing competitiveness*
- *Automated Invoice payment process and improve Invoice payment turnaround*
- *Effective measurement and efficient sourcing of goods and services at the optimum cost.*
- *Ability to identify clinical usage from procedure to patient, on a micro to National level.*

# DoH drivers for the NHS eProcurement Strategy

The e-Procurement strategy was published by the Department of Health in May 2014. The strategy provides guidance to all NHS and private health providers. The strategy will require organisations to adhere to guidance in order to improve supply chain processes that will ultimately save the NHS considerable sums of money and improve patient safety.

- *DoH mandates the adoption of **PEPPOL** standards and **GS1** standards (GTIN's, GLN's and Data synchronization)*
- *Lord Carter report – highlighting the opportunity of saving 20% of 72Bn of procurement by using EDI solutions within the supply chain*
- *New legislation – government EDI adoption using **PEPPOL** standards*
- *DoH creating 6 demonstrator sites (Derby, **Leeds**, North Tees & Hartpool, **Plymouth**, Royal Cornwall, **Salisbury**)*
- *UK government to legislate supplier payment terms to a maximum of 30 days*
- *DoH objectives*

- *1% Improvement in workforce productivity = £400m*

## **Pharmacy** - £6.5bn

- *Prescribing of medicines & Staffing*

## **Procurement** - £9bn

- *Catalogue driven procurement*

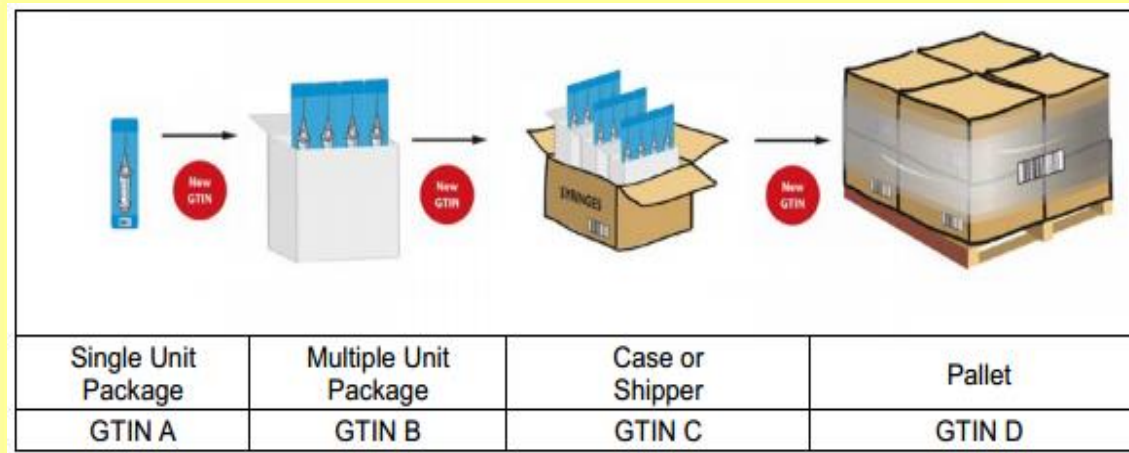

# GS1 Standards

*The GS1 System is the global language which enables interoperability between systems; providing the foundation for efficient and cost effective exchange of products and information between organisations.*

- *Trusts and Suppliers must implement **GS1** data standards – GLN, GTIN Barcodes etc.*
- *Trusts must capture GTIN and UDI data (batch, serial and lot) for implantable devices.*
- *GTIN, GLN and key attributes to be sent on PO between Trust System and Supplier system.*
- *GTIN information provided by the suppliers through the GDSN.*

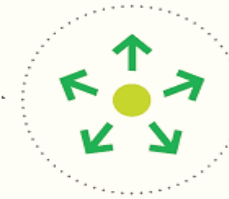

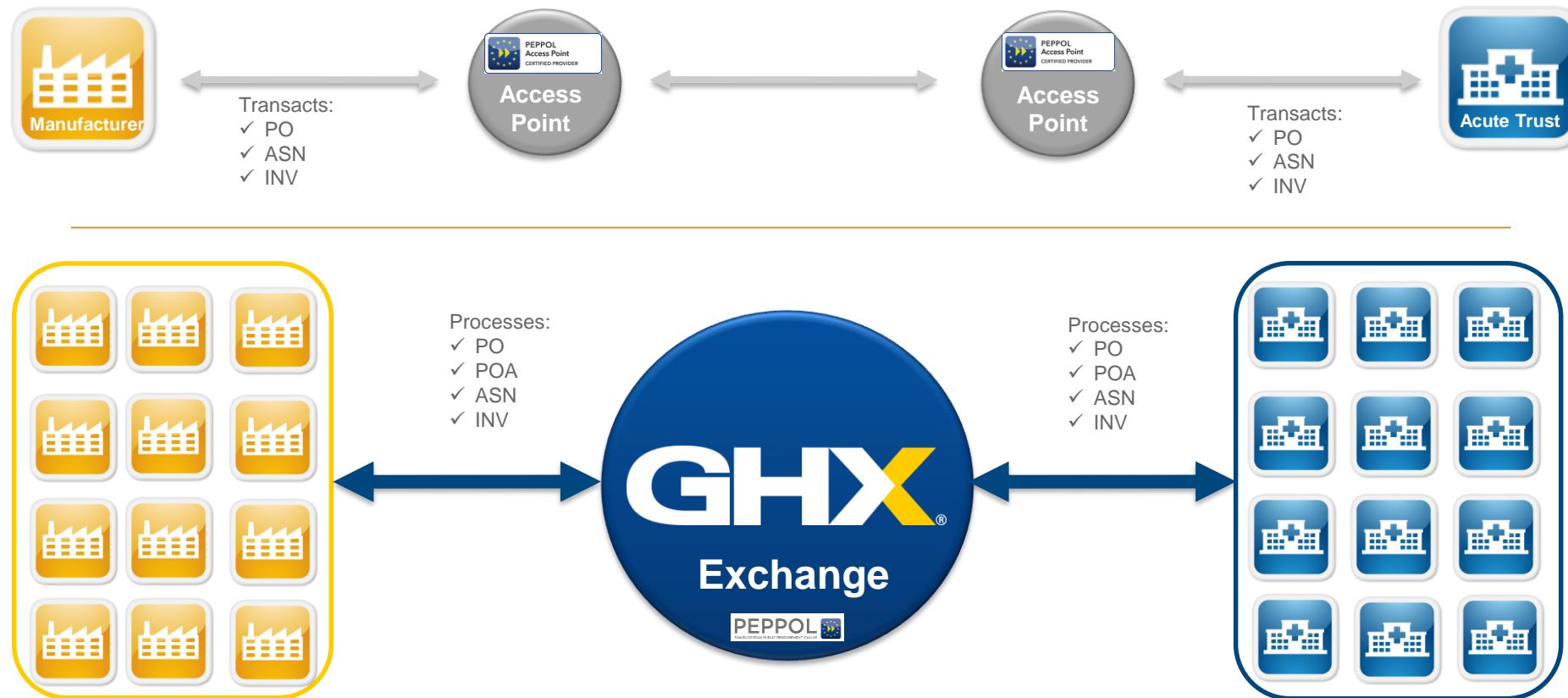

*PEPPOL is a European-wide EDI standard that connects organisations together, so that they can do business electronically using standardised connections for ordering (PO), invoicing (INV) and advanced shipping notifications (ASN).*

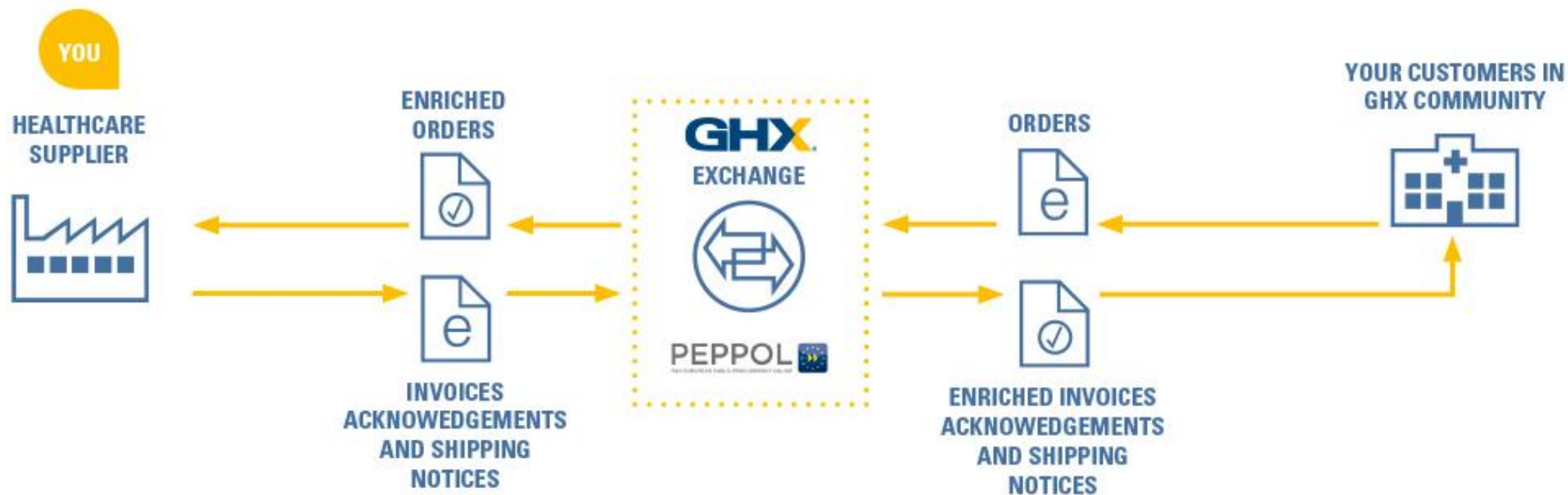

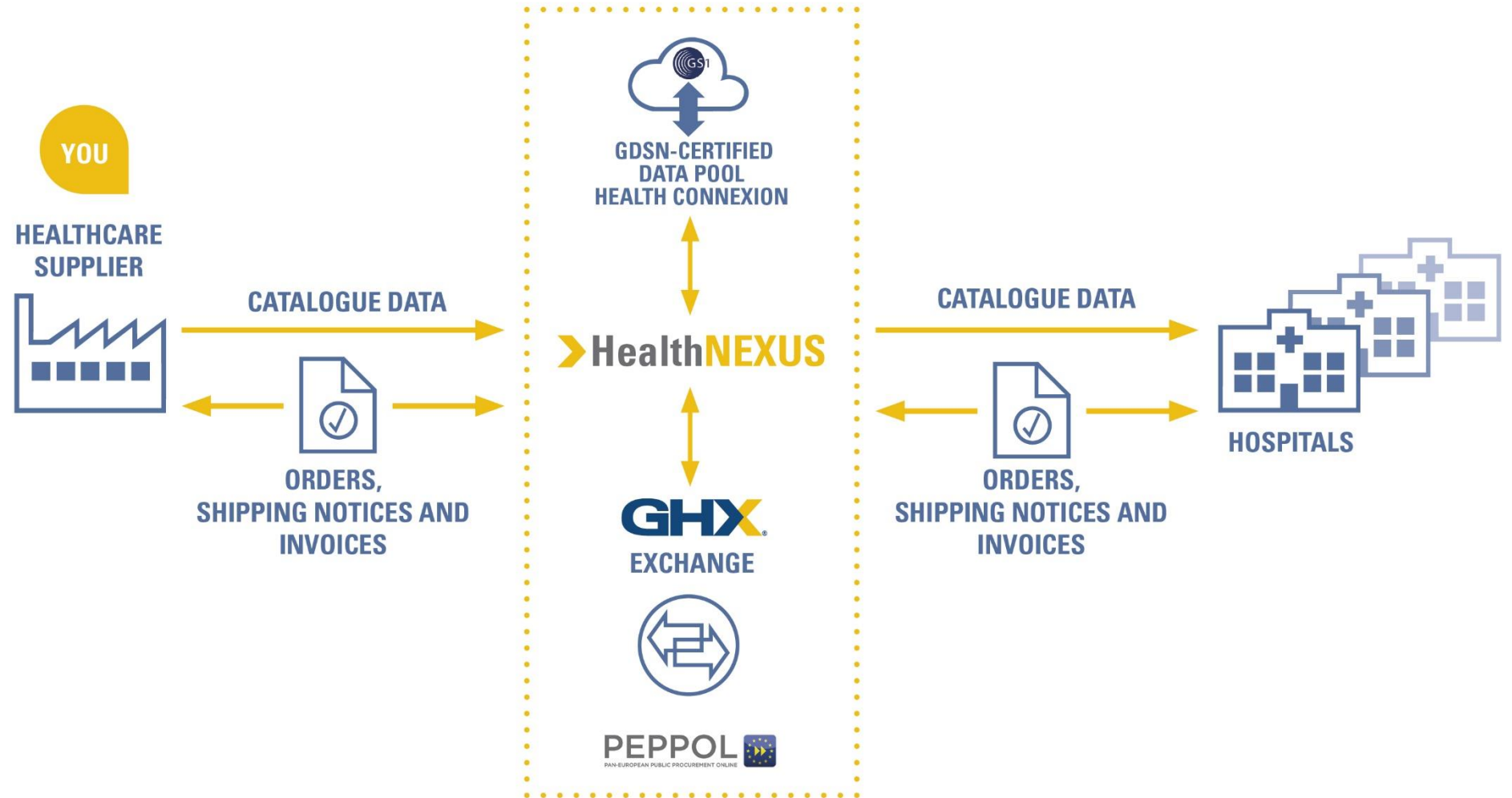

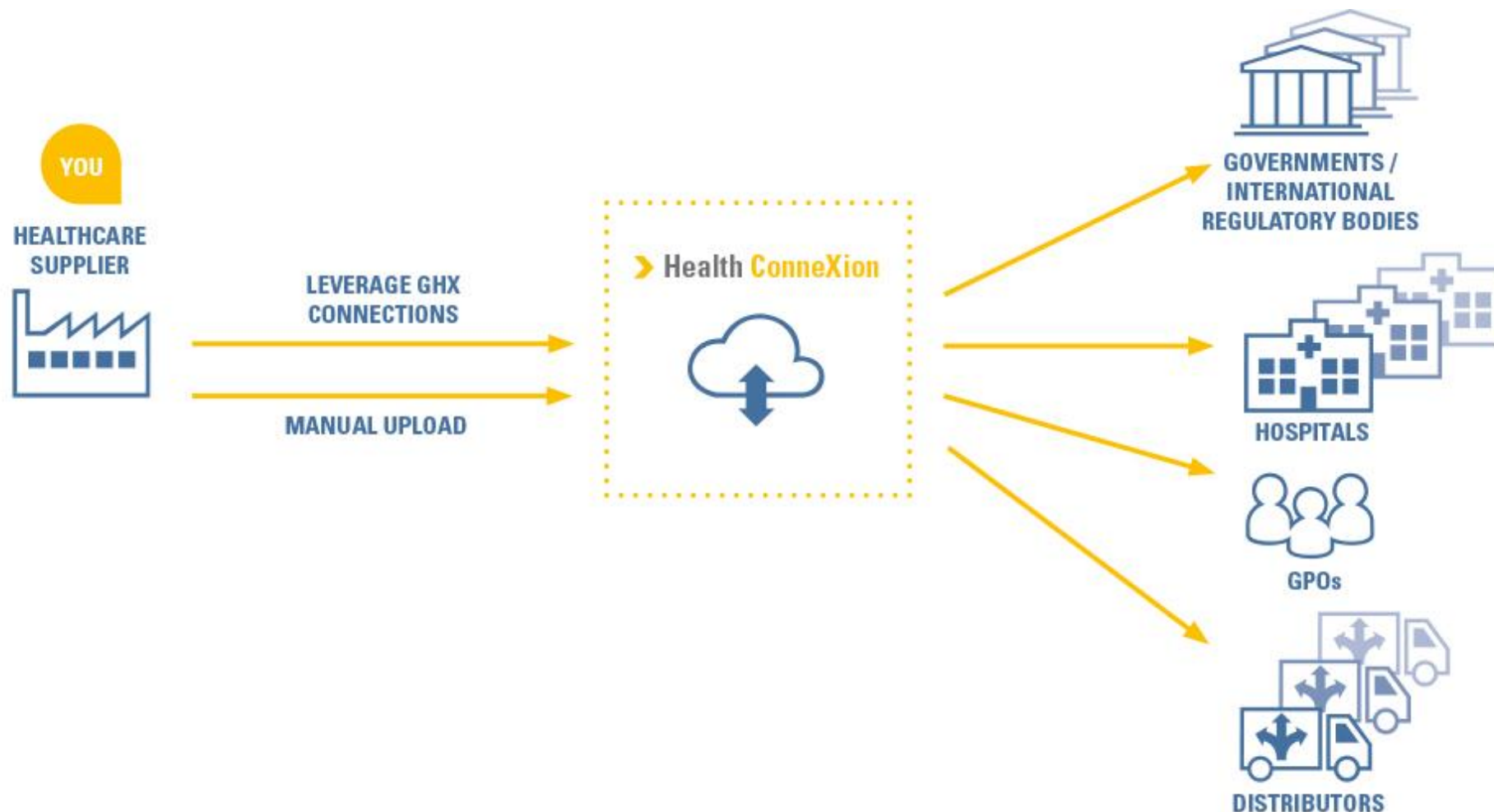
