CO Screen – Steve Hardaker visited a number of companies and Fire & Rescue Services with the primary intention of learning how their Procurement process works and getting feedback on the CO Screen, which he showed to them.

Surprisingly, not one Fire & Rescue Services were interested in the CO Screen as patient assessment tool, with the general response being that their responsibility is to extract the casualties and hand them over to the paramedics; at most they will give oxygen, anything else is delaying handover. However, there was some interest from the perspective of using the CO Screen for assessing fire service personnel following a call out to an incident.

None of the above constitutes a warm lead at this stage but may allow us to get the information in front of the right people and get our products into the procurement process. I will ensure that they are added to our CRM and will follow all of them up.

All of the Fire Services that he spoke to select their equipment through scheduled procurement processes and equipment is not just purchased ad-hoc. This means that we need to do some background work on gaining access to their procurement calendars, which Steve will start with the contacts above. He will then discuss with Catrin and Steve N to develop a marketing plan to contact the rest.
