Claim for Repayment of remission of Import Duties (Including Excise Duties).

I refer to your application dated 12/12/2016 for refund or remission of Import Duties. I intend to refuse your application for repayment because:

Following consultation with the Tariff Classification service, the goods in question have been classified under commodity code 6307 9098 10. This code attracts a duty rate of 6.3%, which means that correct amount of duty has been paid and no refund is due.

Justification - classification has been determined in accordance with the following:-

General interpretative rules (GIR)s

GIR 1 has been used to classify this product by the terms of heading 6307 other made-up articles, including dress patterns.

GIR 6 has been used to classify this product to subheading level 630790 other than elsewhere specified within this heading.

CN code 63079098 other than single-use drapes made up of fabrics of heading 5603, of a kind used during surgical procedures.

TARIC code 6307909810 - nonwovens.

ECJ C-547/13

Exclusions/Comments - the product is excluded from chapter 90 - principles of commission Reg 437/2006 apply here. The product does not have the essential characteristics of the goods covered by chapter 90 i.e. A high finish of manufacture and a high degree of precision in the way they operate.(para 37 of the ECJ in joined cases C-260/00 to C-263/00 of 7 November 2002 and first para of HSENS to chapter 90 general part(1). The products protect the eyes and are essentially an eye mask. The trader has confirmed that the products are made of unwoven lace spun fabric.
