Hi Peter,

Sorry for the delay in responding, we have just resumed today following the Bank Holiday weekend and have had some catching up to do.

We are currently down to just one TOF 3D device in stock, the lead-time on more is approximately 2-3 weeks.

The TOF 3D package complete with cables is available as follows:

- 2510091 - TOF 3D Neuromuscular Transmission Monitor @ £1,400.00+VAT

Accessories included:

2510102 Main Patient Cable

2510103 Stimulation Cable

2510104 Acceleration (AMG) Transducer,

1 x Sealing cover for unused port on main patient cable

1 x Sealing cover for data interface socket

4 x AA 1.5V batteries

Instructions for Use

With regards to replacement cables, the device uses a main patient cable which allows connection of a stimulation cable and an acceleration transducer, all 3 cables are available separately or as a complete bundle. The prices are detailed on the attached price list.

If you wish to use the twitch response monitoring, which is recommend for best performance, you will also need to purchase either of the following accessories:

- **2520110 - Hand Adapter (reusable) @ £38.50+VAT each**
- **2520111 - Thumb Adapters (single use) @ £45.00+VAT / pack of 50**
- **2520112 - Eye Adapters (single use) @ £82.00+VAT / pack of 50**

Note: for hand placement, you can choose either the reusable hand adapter or the disposable thumb adapters, they are not used together.

Viamed does not operate with field sales representatives so is unable to offer on-site product support, such as demonstrations and end-user training, but we can offer you a new device on a 30-day 'Sale or Return' trial. The Sale or Return process allows you to trial a new device for a period of 30-days, covered under the Master Indemnity Agreement for the duration. The trial is without obligation to purchase; if the device proves suitable, we just need a Purchase Order to cover it, if not, we just ask that you return it using a traceable courier service with the original accessories (with the exception of any disposable items) in its original packaging.

The device uses standard paediatric sized electrodes, which we don't supply but are readily available through your usual channels. If you wish to mount the device onto an I.V. pole, we also have a pole mounting clamp available at £66.75+VAT.

I have attached an Instruction Manual for reference, which does detail the Manufacturer approved cleaning products, however, Clinell Universal Wipes are not listed. The difficulty for manufacturers is that with the multitude of cleaning agents on the market, it is not viable to test against all of them. I will ask the question to my Director to see whether the manufacturer will consider approving Clinell wipes, in the meantime, you might want to see whether the detailed cleaning agents are available in the Trust and whether Infection Control can advocate their use in place of Clinell Universal Wipes.

Finally, I will be able to get the PAQ form to you this week. This is a new product to us and the form is still being prepared and authorised.
